Message from the President

Greetings, Association Members!

I greatly regret that I am the one to write this president's message. I am only serving as interim president to our organization because of

interim president to our organization because of the unexpected death of our elected President, Jean-Pierre Sainton, who died last August. He had been elected for a second presidential term at our June meeting in Puerto Rico, and as Vice President I stepped in to cover the remainder of his term. There is a tribute to him and a discussion of his career elsewhere in this bulletin, where you can read of his many accomplishments as a scholar and a leader and of his special interest in the events of May 1967 in Guadeloupe. He is missed, and I know we all wish he was still with us to write this message himself.

Despite this difficult turn of events, the ACH continues its recovery from the challenges of the global pandemic. Our meeting in Puerto Rico, if small, was very successful and our membership numbers remain strong. Our various prizes continue to recognize exceptional research while our Gould-Saunders Travel Fund assists members (especially junior colleagues coming from the West Indies) to attend our meetings. We hope members living and working in the Caribbean will bring that award to the attention of their younger colleagues and encourage them to apply.

We look forward to meeting again in the Spanish Caribbean, this time at the University of Magdalena, in Santa Marta, Colombia, in late May. I do hope you will join us for what promises to be an excellent meeting. Two consecutive Spanish-language hosts is a little unusual, but a quick look at our previous 54 meetings shows that it is not unprecedented, and we only met five times in a Spanish-language location in the last 25 years. We have also been to Colombia only once before, in 2005. Even as we prepare for our May meeting—see the draft program elsewhere in the bulletin—we are looking ahead to 2025. If you would like to host our meeting—or find out more about doing so—please be in touch with me or other members of the Executive Committee.

My thanks to all of you who work to support our organization, but particularly our officers and members at large on the Executive Committee. Javier Alemán Iglesias, newly elected to the EC after coordinating local arrangements in Puerto Rico, kindly volunteered to take over the Vice President position after I stepped into my current role; Randy Browne continues to do superb work as Secretary Treasurer; and Claire Palmiste has proven an organized and gracious Conference Coordinator in the planning of ACH 2024. This organization would not run without their efforts as well as those of members-at-large Rose Mary Allen, Terencia Joseph, and Marjoleine Kars, and without your participation and support as our members.

In Memoriam: Jean-Pierre Sainton (1955-2023) By Clara Palmiste

On Tuesday, 22 August 2023, we were deeply saddened to hear about the passing of our colleague and friend, Jean-Pierre Sainton, a university professor and activist involved in cultural, social, and political changes in Guadeloupe.

Jean-Pierre Sainton worked to promote a better understanding of the history of the West Indies, first with his thesis on *Les Nègres en politique* (1997), then with *Histoire et civilisation de la Caraïbe*; *Territoires de l'histoire antillaise*, which have paved the way for a renewed and critical approach to the political, social and cultural history of the French West Indies. Jean Pierre was a historian of great rigor and intellectual integrity, concerned with the transmission of knowledge and with the future of West Indian societies.


He shed light on the events of May 1967 in Guadeloupe and explored the issues surrounding the departmentalization of the French West Indies during the pivotal period of the decolonization movements worldwide (*La décolonisation improbable*, 2012). The latest book he edited with Elsa Dorlin and Mathieu Rigouste, *Mai 67. Massacrer et laisser mourir* (2023), is a synthesis of this painful episode in the history of Guadeloupe. The book won the Fetkann-Maryse Condé literary prize. Sainton was concerned with the "silences of history" and compiled a collection of testimonies available on the online section of the Bettino Lara Media Library.

Thanks to his determination, he contributed to setting up the Camp Jacob campus in Saint-Claude and in creating the multi-disciplinary Department of Humanities at the University of the Antilles. He was also instrumental in promoting Guadeloupe's culture and heritage through his involvement in the creation of the Performing Arts degree. His work has inspired a number of national and international researchers, and he directed a number of projects, publications, most recently on Interpersonal Networks in the West Indies (Rezo).

He was also President of the Association of Caribbean Historians.

As a great master of martial arts, he instilled a whole philosophy and ethic in the new generation. We must also honor his extreme humility, his profound generosity, and his ability to manage ambitious projects at the university and association levels. The academic world has lost not only a historian and a researcher, but also an enlightened man of great intellectual generosity, with a deep respect for Guadeloupe's cultural values.

The ACH Executive Committee is pleased to announce that the 55th Annual Meeting of the Association of Caribbean Historians will be held in Santa Marta, Colombia, from Sunday, May 26 to Thursday, May 30, 2024. On-site registration and check-in opens Sunday afternoon. The conference fête, our annual dinner and dance (which is highly recommended and a central feature of this organization) will be held on Thursday evening, May 30. An optional field trip is scheduled for Friday, May 31.

CONFERENCE VENUE AND ACCOMMODATIONS

The conference will be held at the University of Magdalena (Universidad del Magdalena), 15-20 minutes from the historic center of Santa Marta.

The Local Organizing Committee (LOC) has selected **one primary hotel**, with **two alternatives**, and secured **discounted ACH rates** for each. Transportation to and from the conference venue and these three accommodations will be provided. Note that if you choose to stay elsewhere, you will need to arrange your own transportation to and from the conference venue. There are many other hotels, short-term rentals, etc. at various price points within walking distance of the official hotels.

This modern hotel in downtown Santa Marta features 125 rooms, a rooftop pool and bar, gym, free wifi, and two restaurants. ACH members who book directly with the hotel will receive free buffet breakfast. Nightly rates for a single guest range from 240,000 COP (Colombian pesos—about \$62 USD) for a "superior king" to 290,000 COP (\$74 USD) for a "junior suite." Additional persons can be added for 80,000 COP/night (\$21 USD). These rates do not include IVA of 19% or optional hotel insurance. The AC Hotel is also in downtown Santa Marta, about five minutes walking distance from the Best Western Plus. Features 120 rooms, a pool, four restaurants/cafes, free wifi, and gym. Nightly rates for one or two guests are 300,000 COP for a "superior king" or 350,000 COP for a "premium twin," with an additional charge of 100,000 COP/night for another guest. These rates do not include tax or optional hotel insurance. Buffet breakfast is included. A smaller hotel (60 rooms) in the center of Santa Marta's historic district, about 10-15 minutes walking distance from the Best Western Plus and AC Hotel. Features rooftop pool and terrace, free breakfast and wifi, restaurant, and business center. ACH rates are 250,000 COP/night (not including tax). For reservations, email <u>mercadeo@hotelcatedralplaza.co</u> and request the University of Magdalena rate.

TRAVEL TO AND WITHIN COLOMBIA

Santa Marta (Aeropuerto Internacional Simón Bolívar–SMR) is well connected to airports in the Caribbean, United States, and Europe, primarily via El Dorado airport in Bogotá. For visa requirements and information, see: <u>https://www.cancilleria.gov.co/en/procedures_services/visa/requirements</u>.

Official taxis are affordable and widely available at the airport (about 15-20 minutes) and throughout Santa Marta. Payment is only accepted in cash (Colombian pesos). While taxis can be hailed on the street, for safety it is recommended to request them via phone or app (hotels, restaurants, and other businesses can also request a taxi for you). Confirm the fare with your driver before starting your trip.

The LOC will provide transportation to and from the three hotels above to the university each day. Transportation schedules will be shared with participants in advance of the conference.

MEMBERSHIP AND CONFERENCE REGISTRATION FEES

All conference attendees and presenters **must be current members of the ACH**. Those who joined at or before the last conference in June 2023 will need to renew at or before this year's meeting; those who joined since the 2023 meeting have a valid membership until just after the conference in Santa Marta. There are six categories of membership (all amounts below appear in U.S. dollars):

- Non-tenured faculty, Caribbean-based lecturers (\$50 a year): for faculty, public history, or governmental positions.
- Tenured professors and other established researchers (\$75 a year): for tenured faculty, public history, or governmental positions.

- Teachers (primary/secondary), students, and retirees (\$25 a year): a special rate for primary/ secondary teachers; graduate and undergraduate students, and retirees.
- Institutional Members (\$100 a year): for colleges, universities, libraries, museums, and other cultural and educational organizations.
- Benefactor (\$150 a year): a higher category of giving to support the organization's activities.
- Life Membership (\$500): the best membership bargain—equivalent to 10 years of regular annual membership, but valid for life.

In addition to annual membership, there is a **registration fee** for the conference itself to defray local expenses. Registration fees for the 2024 conference appear below. While participants can register at the conference, <u>speakers and chairs must do so in advance</u>, and <u>pre-registration online is encouraged for everyone</u>—presenting or not—to gain access to all pre-circulated conference papers. All those presenting or chairing sessions at the conference MUST renew their membership and register for the conference by the time their pre-circulated papers are due on March 15, 2024.

ACCESSING PRE-CIRCULATED PAPERS

ACH presentations include both a pre-circulated 25-page paper and a brief (10 minutes or less) conference presentation. The ACH is making pre-circulated papers available online for those who pre-register. Once the ACH receives your completed registration, you will receive a password to access the portion of the website where papers are housed. Please be aware that papers are not due until March 15; they will not, as a result, be available online until late April. You can pre-register for the conference online at http://www.associationofcaribbeanhistorians.org. You will be asked to complete an electronic registration form and pay with a credit card.

ACH Conference Presentation Guidelines

A number of 2024 presenters are new to the ACH or returning after some time away. Please take a few minutes to review the conference paper procedures:

1. Every presenter must be a member of the ACH. If you are not currently a member, you can join through the ACH website, <u>http://www.associationofcaribbeanhistorians.org</u> or in person during registration at the conference (all presenters and chairs must register by March 15, 2024).

2. ACH papers include both a pre-circulated paper and a brief presentation at the conference. Papers can be written in English, French, or Spanish, and can be no longer than 25 typed, double-spaced pages using 12-point font. This includes notes and references. <u>ALL</u> presenters must strictly adhere to this format—papers longer than 25 pages or not double-spaced will be returned for editing.

To allow time to format and post material, presenters should email their papers (as a Microsoft Word file) NO LATER THAN March 15, 2024 to: Claire Palmiste, ACH Conference Coordinator, at <u>achconference@gmail.com</u>

PLEASE NOTE: You will be asked to register for the conference and to pay for registration at this time. Presenters who do not provide papers by the March 15, 2024 deadline will be removed from the program and will not be permitted to present.

3. Conference papers posted online will be password protected; only after someone has registered and paid for the conference will they be able to access this portion of the website.

4. Presentations at the conference should serve to briefly introduce information in pre-circulated papers and as such are limited to 10 minutes. It is very important that all presenters strictly adhere to these time limits, and panel chairs will be charged with ensuring that panels proceed on time. Please hand a hard copy of your presentation to translators to facilitate their job.

5. Presentations at the conference can be in English, French, or Spanish; simultaneous translation of all presentations will be provided.
